Required Documents for Company Registration

- Passport or copy with at least 6 months validity
- 1 to 6 partners, with at least 10% shares each
- No other documents are needed.

Does Company Registration Mean Residency?

No. To operate your business in Oman, you must get legal residency.

After receiving your residency, you can:

- Open international bank accounts
- Buy or rent property and vehicles.
- Start official business activities.

Type of Company You Will Register

If you want **100% Foreign ownership** without an Omani sponsor (and the trouble that comes with it) and don't want to block a large amount of capital:

✓ The correct choice is a **Limited Liability Company (LLC)**

similar to Google's structure.

Company Capital

Grade	Capital (OMR)
Grade 4	Less than 25,000
Grade 3	25,000–50,000
Grade 2	50,000–100,000
Grade 1	100,000–250,000
Excellent	Over 250,000

Company Grade Differences in Oman

In Oman, companies are classified by the Ministry of Commerce, Industry and Investment Promotion (MOCIIP) into grades that reflect:

- The scale of the business
- The amount of capital
- Number of staff allowed
- Legal and financial benefits

Excellent Grade

- Large companies with high capital and revenue
- No limit on employee visas
- Required for major government projects
- Must have local office and real operations

Grade One

- Medium to large businesses
- Moderate employee visa capacity
- Can participate in large private and mid-size government projects

Grade Two

- Medium-size businesses
- A limited number of staff visas
- More affordable than Grade 1 or Excellent

Grade Three & Four

- Small businesses and startups
- Lower cost, fewer employee visas
- Best for solo entrepreneurs, local services, or online shops.

Upgrading Your Company Grade

Yes, you can upgrade your company grade later.

From → To	Grade 3	Grade 2	Grade 1	Excellent
From Grade 4	100 OMR	150 OMR	250 OMR	600 OMR
From Grade 3	–	100 OMR	200 OMR	550 OMR
From Grade 2	–	–	150 OMR	500 OMR
From Grade 1	–	–	–	400 OMR

You can start with Grade 4 and upgrade any time you are ready.

Can My Family Get Residency Too?

Yes. Each company shareholder can apply for family residency:

Family Member	Cost
Spouse	150 OMR
First Parent	150 OMR
Second Parent	100 OMR
Children under 21	100 OMR

Bank Account in Oman

Opening an international **company bank account** is **required** to start any business in Oman.

However, because of problems faced by both foreign and local investors (like cheque misuse), Omani banks are **strict** when opening company accounts.

Banks must ensure **your company is real and operating** before approving a business account.

How Long Does It Take to Open a Bank Account?

Type	Time
Personal account	1 to 3 days
Company account	1 week to 1 month
Cheque book	1 week (for company accounts only)

Chequebooks are only issued for company accounts.

To open a company account, all partners must have residency and be present in Oman.

Company and Residency Validity

- Company license must be renewed **every 3 years**.
- Residency (for investors and family) must be renewed **every 2 years**.
- A person with **family residency cannot work** in Oman. To work, they must change it to a **work permit**.
- Entry/exit of shareholders is subject to **strict laws** and must be planned carefully.

Activities Reserved for Omani Citizens

Not all activities are open to foreign investors.

Here are examples of business activities **that are only allowed for Omani national companies.**

Oman's Free Zones

Royal Decree 105/2020, issued in August 2020, created Oman's Public Authority for Special Economic and Free Zones.

Free Zone Benefits:

1. Tax exemption for 30+ years
2. 100% foreign ownership
3. Full profit and capital repatriation
4. Investor-friendly legal environment
5. 0% import/export duty

Mainland vs. Free Zone

- Free Zone companies cannot operate on the mainland.
- To sell inside Oman, they must **register again in the mainland** and pay customs + taxes.
- Each option has pros and cons.

Oil companies usually register in **free zones**.

Service companies register in the **mainland**.

Free zones are ideal for export/import or manufacturing due to tax and customs exemptions.

Total cost to register a company, rent an office for 3 years, and a 2-year residency in Free Zone: **6,000 OMR**

Tax System in Oman

- **Free Zone:** No tax for 15–30 years (renewable depending on the zone)
- **Mainland:** 15% corporate tax on net profit (must be declared within 6 months of fiscal year-end)

Many tax advisors are licensed to handle submissions to the Tax Authority.

Share Transfer Rules in LLC Companies

To transfer shares in an LLC, you must have:

- Rental contract
- Municipality license
- 6 months of company bank transactions
- At least one Omani employee

✓ With all documents and buyer/seller present, shares can be transferred at the Ministry.

✗ If anything is missing, **the process becomes expensive and complicated** — sometimes, **registering a new company is cheaper.**
